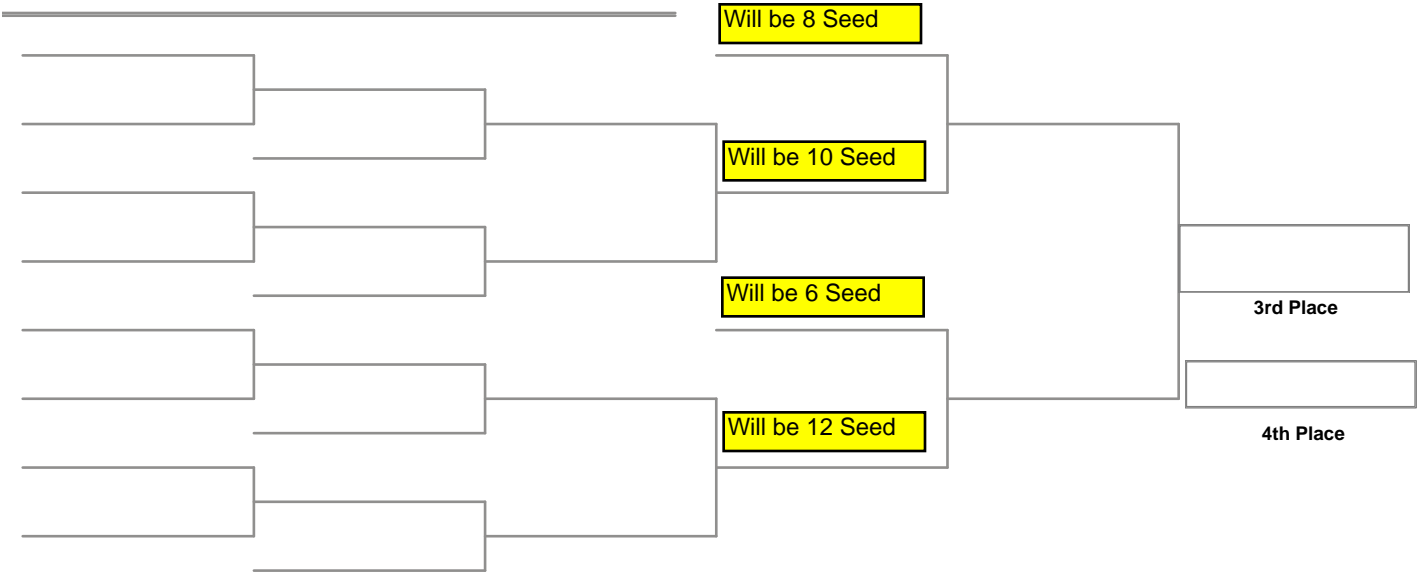
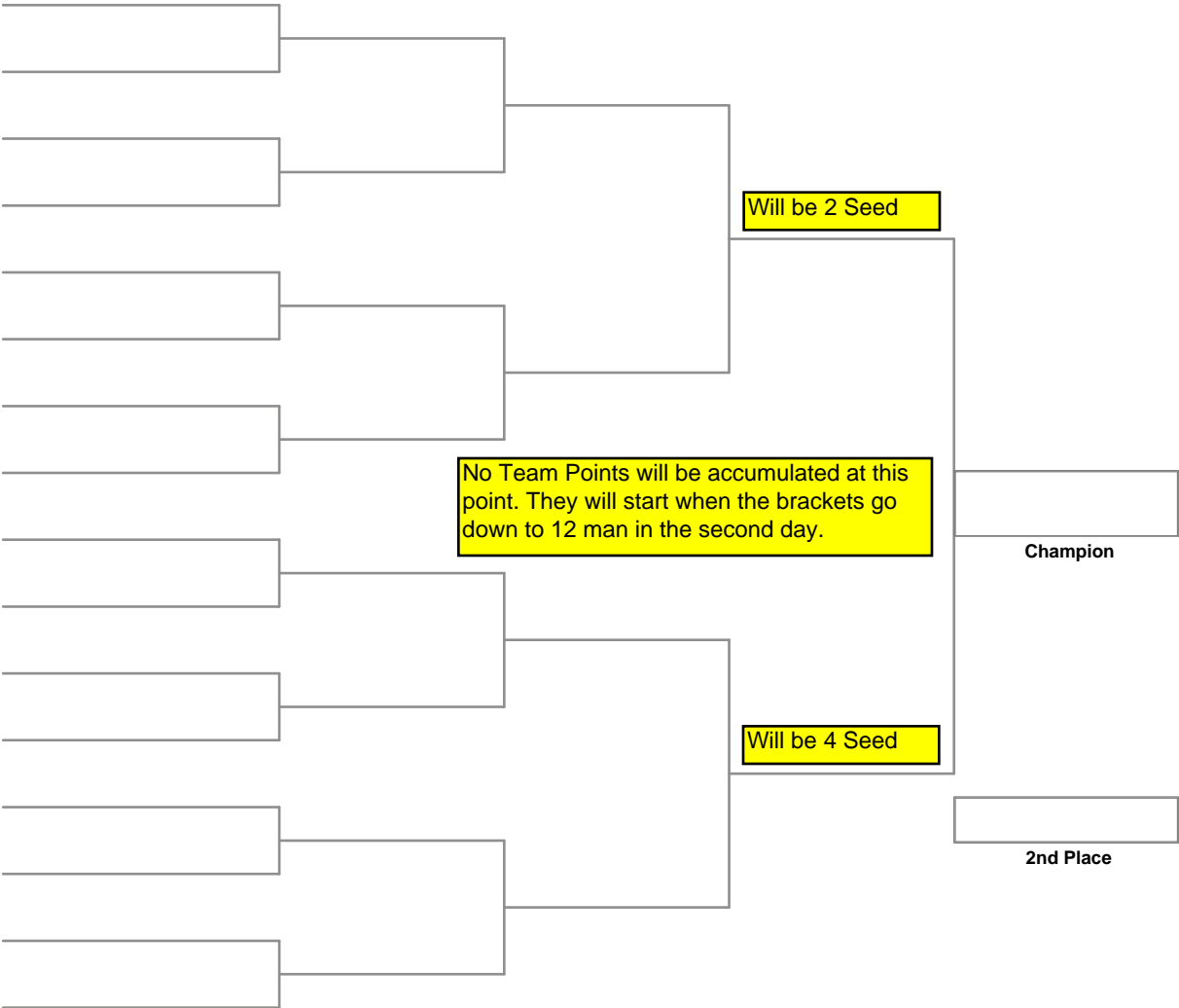


This is the set up for the second day of the Varsity tournament in the East division

EAST

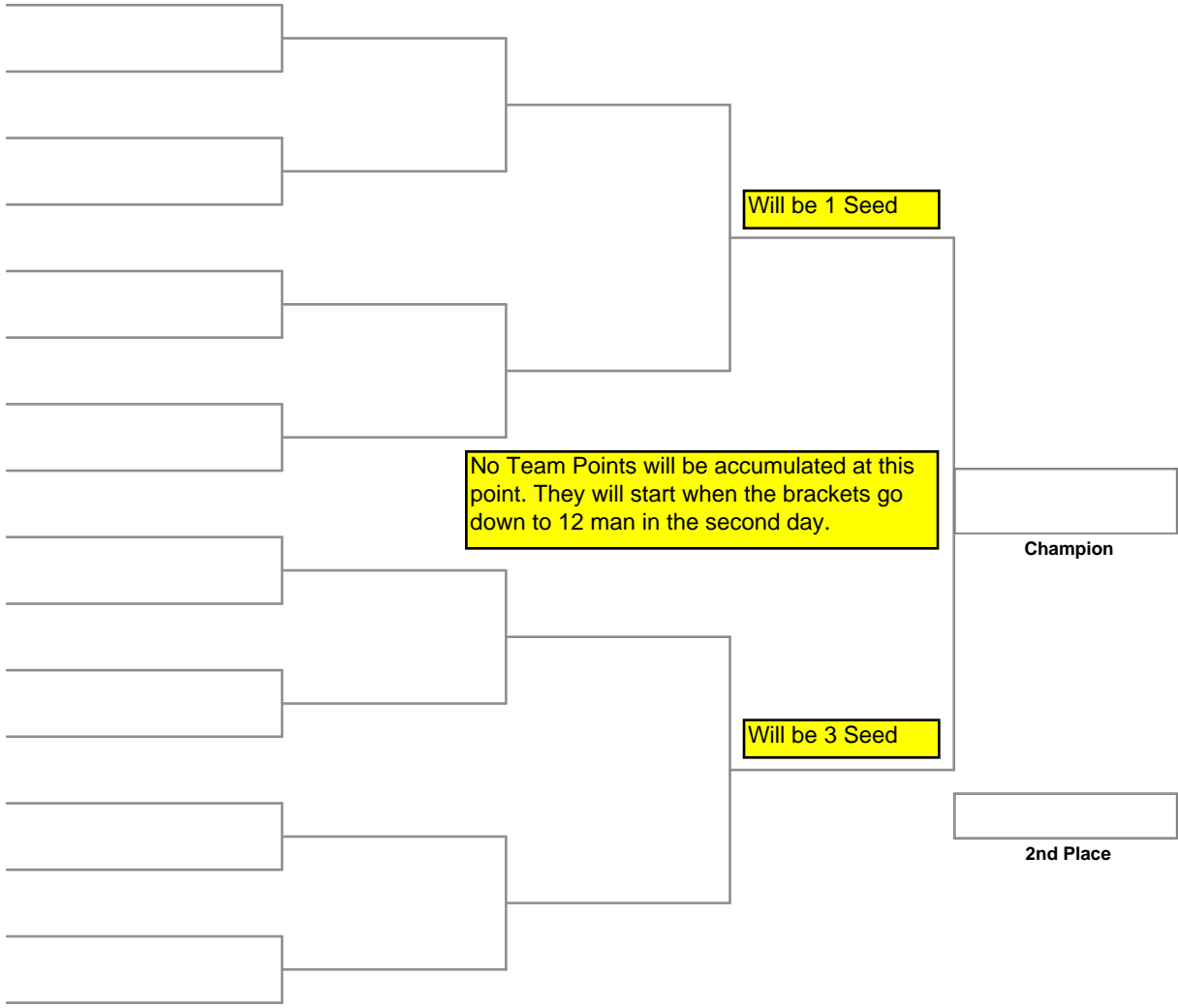

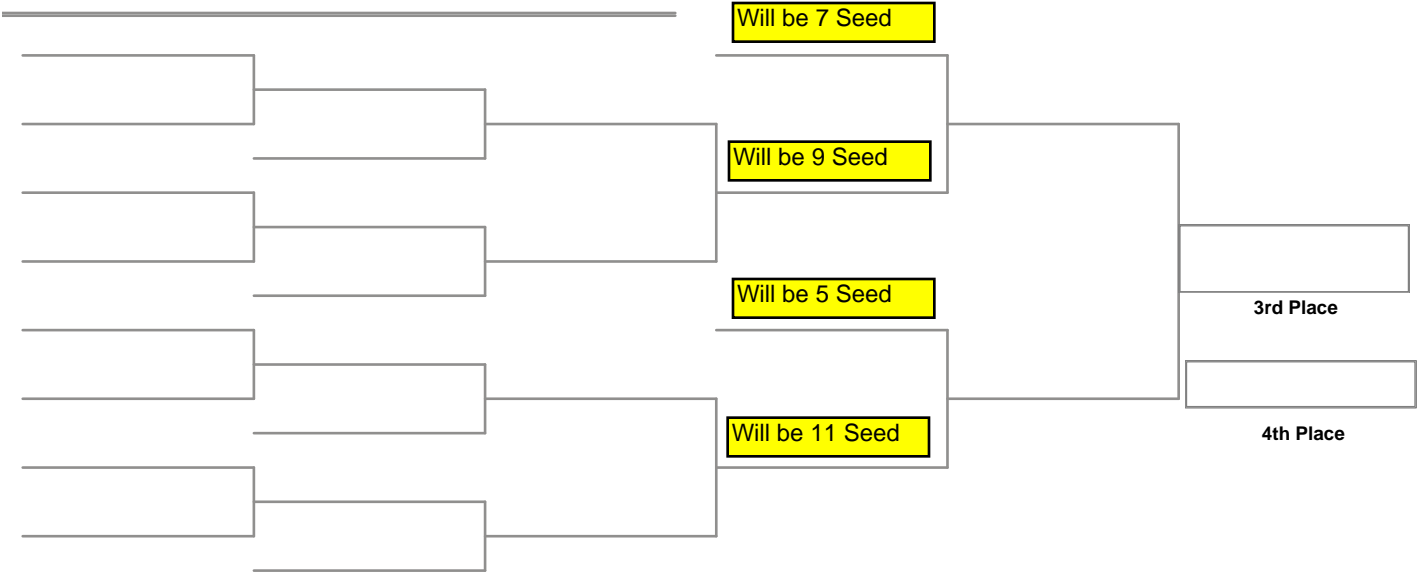
This is the set up for the second day of the Varsity tournament in the West division

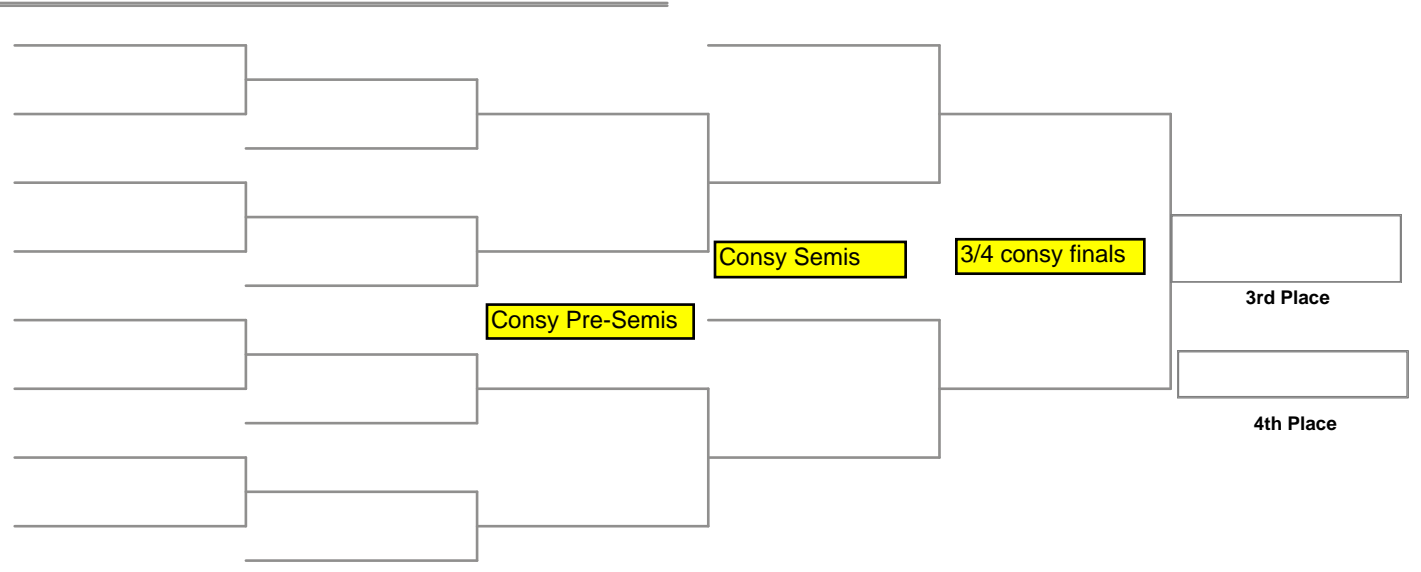
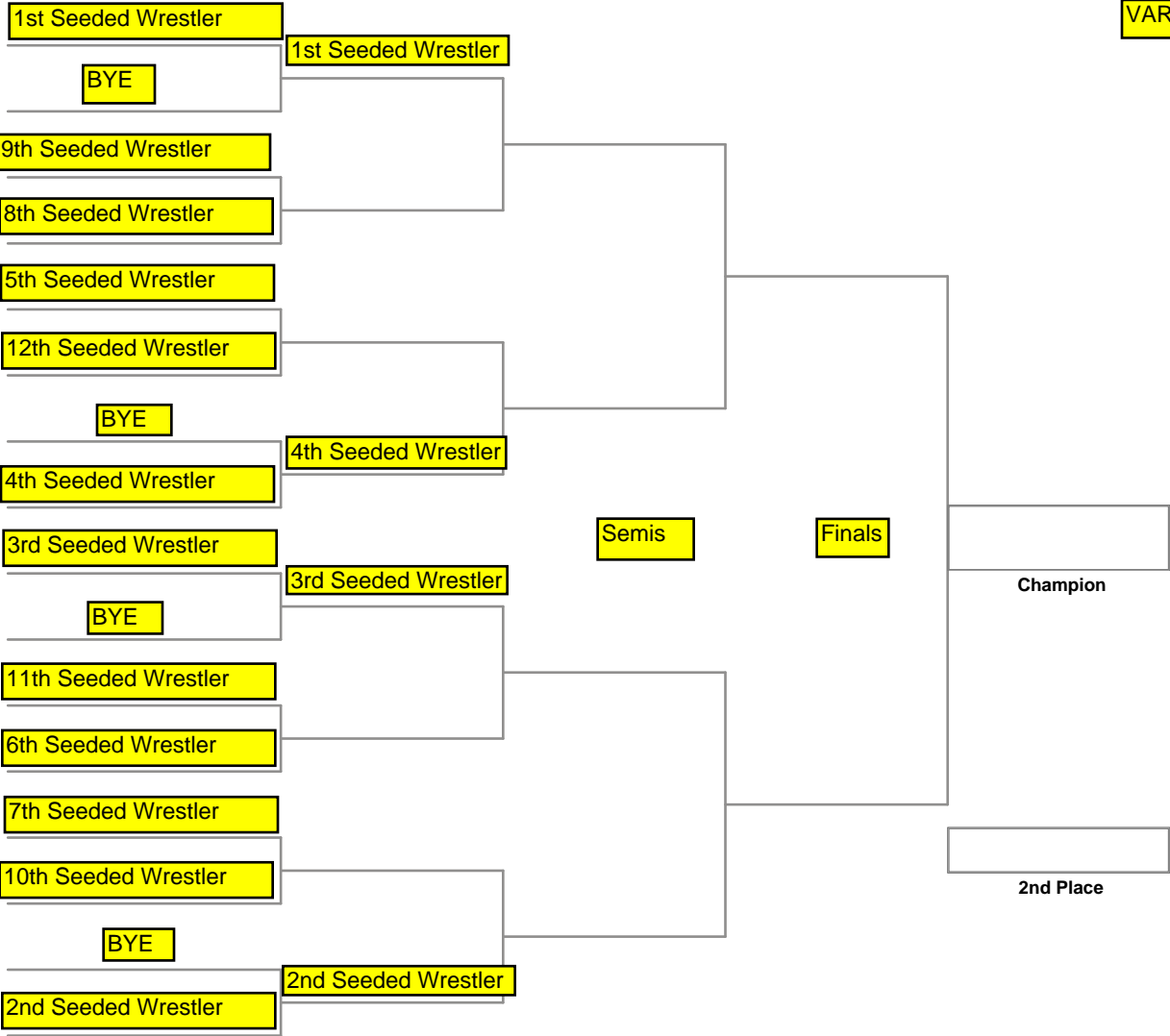


No Team Points will be accumulated at this point. They will start when the brackets go down to 12 man in the second day.



VARSITY TOURNAMENT

Team Points (based on NFHS rules):

Advancement in Championship Bracket = 2 pts

Advancement in Consolation Bracket = 1 pt

Championship bye followed by a win = 2 pts

Consolation by followed by a win = 1 pt

Technical Fall = 1.5 pts

Major Decision = 1 pt

Fall = 2 pts

Default = 2 pts

Forfeit = 2 pts

Disqualification = 2 pts

Placement Points

1<sup>st</sup> = 16 pts

2<sup>nd</sup> = 12 pts

3<sup>rd</sup> = 9 pts

4<sup>th</sup> = 7 pts

5<sup>th</sup> = 5 pts

6<sup>th</sup> = 3 pts

7<sup>th</sup> = 2 pts

8<sup>th</sup> = 1 pt

As I stated in the meeting, if a wrestler makes it to the Semi-Final he will accrue 6<sup>th</sup> place points for there team so each wrestler will add 3 pts to there team score.

Whatever wrestlers make it to the finals will automatically receive an additional 9 pts. Whoever wins the finals will receive an additional 4 pts for winning.

Any wrestler making it to the consy pre-semis will accrue 1 point because they are guaranteed to place 8<sup>th</sup> or better. Once those consy pre semis winners advance they will add an additional 2 pts because they are guaranteed 6<sup>th</sup> place or better.

The winners of the consy semis will add an additional 4 pts because they are guaranteed 4<sup>th</sup> place or better and the winner of the 3/4 place match will gain 2 more points.

The winner of 5/6 will gain 2 more points and the winner of 7/8 will gain 1 more point.

Throughout all this wrestlers can still gain more points by Tech Falls, Falls, Defaults, DQ's and major decisions. Also advancement points within the bracket. They can also lose points by flagrant misconducts and unsportsmanlike conduct penalties.
